- If VDU corrective spectacles are recommended, you are legally obliged to supply them, so just present your employee with a Spectacles Voucher to cover the cost - it's that simple.



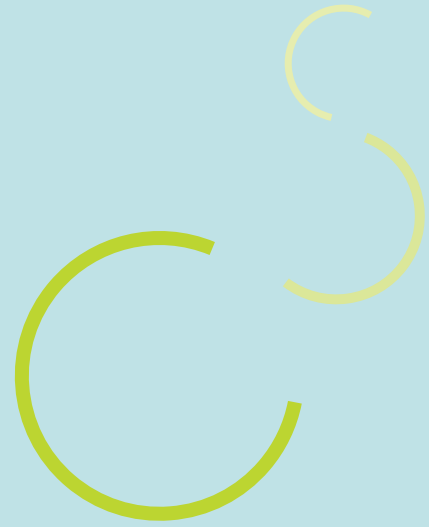
